

## STAFF SELECTION COMMISSION

### Final Result of Sub-Inspectors in Delhi Police, CAPFs and Assistant Sub-Inspectors in CISF Examination, 2015.

\*\*\*\*\*

The Staff Selection Commission conducted a Written Examination for recruitment of Sub-Inspectors in Delhi Police, CAPFs and Assistant Sub-Inspectors in CISF on 21.06.2015 (Paper-I) and Paper-II on 30.08.2015. Result of Paper-I & Paper-II was declared on 27.07.2015 & 19.11.2015(DME) / 07.12.2015(RME), respectively. All candidates who qualified in PST/ PET and who were found FIT in Medical / Review Medical Examination, qualified for Interview, without any cut-off marks in Paper I +Paper II.

2. Based on the merit-cum-preference, candidates have been finally selected and allocated to the following posts that were advertised :-

A-Sub-Inspector in Delhi Police

B-Sub-Inspector in Border Security Force (BSF)

C-Sub-Inspector in Central Industrial Security Force (CISF)

D-Sub-Inspector in Central Reserve Police Force (CRPF)

E-Sub-Inspector in Indo-Tibetan Border Police (ITBPF)

F-Sub-Inspector in Sashastra Seema Bal (SSB)

G-Assistant Sub-Inspector in Central Industrial Security Force (CISF)
