The abovenamed 34 candidates will be considered for provisional appointment as Senior Personal Assistant, subject to availability of vacancies, (after appointment of 16 candidates mentioned in List-I) on the condition that they will have to qualify Typing Speed Test on Computer at a speed of 40 wpm (with less than 3 percent mistakes of the total words typed) within one year from the date of their appointment, failing which, their provisional appointment may be liable to be discontinued and they may be appointed on regular basis and put on probation only after they qualify the Typing Speed Test on Computer.

The above panel of candidates for consideration of appointment to the post of Senior Personal Assistant will be valid for a period of one year w.e.f. 01.09.2020.
